WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 S.S.M. College of Education, VPO-Makrauli Khurd, Distt.-Rohtak, Haryana (HR-1674) had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. Course of one year duration with an annual intake of **100 (One Hundred only)** students on **15.5.2008**.

2. AND WHEREAS the recognition of the institution for B.Ed. course was refused vide NRC's order dated 23rd June, 2009.

3. AND WHEREAS the institution has preferred an appeal on **26.8.2009** against the said order to the Appellate Authority. The appeal of the institution was accepted and set aside NRC's order dated 23.6.2009 and remand back case to NRC to issue Letter of Intent prior to grant of recognition under clause 7(9) of the NCTE Regulation vide order dated 5.3.2010.

4. AND WHEREAS the matter was placed in **157th NRC Meeting held 24th to 27th March, 2010** and as per decision of the Committee the institution was directed vide letter dated 13th April, 2010 to **appoint Faculty as per NCTE norms for B.Ed. and submit the same to NRC for further action.**

5. AND WHEREAS the original file of the institution, reply of the Institution along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the Northern Regional Committee in its **163rd Meeting held from 29th to 31st July, 2010** and the committee decides to issue letter under clause 7(11) of regulations 2007.

6. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **S.S.M. College of Education, VPO-Makrauli Khurd, Distt.-Rohtak, Haryana (HR-1674)** of one year duration with an annual intake of **100 (One Hundred) Students** under clause 7(11) of NCTE Regulations, 2007. **The decision of the Council would, however, be operative from the date of withdrawal of the ban on further recognition of B.Ed course in the State of Haryana.**

- (i) Order for recognition will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.
- (ii) The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010.
- (iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007.

7. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
8. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
9. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
10. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
- Copy of the Application Form
 - Land and Building Particulars
 - Staff Profile
 - Recognition letter
 - Information for having fulfilled the norms & standard and other required conditions.
11. In case if the land is in the name of the Society, the institution must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
